HABITAT PROTECTION AND BIODIVERSITY POLICY

ALEATICA is aware of the environmental impacts generated by its operation and recognizes the importance of preserving habitats and biodiversity to ensure sustainable development; therefore, through this Policy it manifests the commitment to respect and preserve the habitats and biodiversity of the territories in which the company operates.

ALEATICA's guiding principles are:

- a. Comply with the applicable local regulations and the indicators of international sustainability standards and frameworks, reported in the Non-Financial Annual Report of ALEATICA -Spain Law 11/2018, Global Reporting Initiative (GRI), Sustainability Accounting Standards Board (SASB), Global Real Estate Sustainability Benchmark (GRESB) and Task Force on Climate-related Financial Disclosures (TCFD).
- b. Incorporate the preservation of the biodiversity in the company's strategic planning, decision making and risk management.
- c. Designate economic, human and technical resources to prevent, minimize and offset the effects on the habitats and biodiversity that may be caused by the activities carried out in ALEATICA's Business Units.
- d. Promote the preservation and development of habitats and biodiversity.

To operate by the above mentioned principles, ALEATICA will over time assume the following commitments:

- 1. Identify, evaluate and control the habitat and biodiversity risks arising from the company's operations, in order to prevent the impacts as much as possible and improve implementation of controls in all phases of the infrastructure projects.
- 2. Identify, evaluate, mitigate and offset the impacts on the habitats and biodiversity resulting from the company's operations.
- 3. Participate in and/or create research, conservation and awareness projects for conservation of biodiversity in the territories where the Business Units operate.
- 4. Collaborate with local, national and international interest groups to develop programs and projects that make is possible to attend to the risks and impacts on biodiversity and promote conservation and development in the territories where the company operates.
- 5. Establish indicators and objectives with criteria for assessment and follow-up on matters related to habitats and biodiversity.
- 6. Communicate, both internally and externally, the projects and programs implemented with respect to habitats and biodiversity, as well as the progress made on the indicators and objectives.
